- Selling both steer and heifer calves
- Calves will be sorted by weight, type, and sex.
- Sale cost will be \$27/head. This includes sale barn's commission and insurance, and sale administration.
- **An additional \$50 per head fee will be assessed to all cattle that are deemed ODDS by sale management. ODDS are cattle that are not Hereford appearing, have hanging bags, horned or not properly dehorned, bad feet, bad eyes, sick, extremely thin or are absolute terrible quality. Cattle under 300 pounds may also be considered an ODD!**
- Check off will be charged at state of origin rate. Ex: Illinois is \$1.50/hd
- Yardage will be charge at \$1.50/hd.
- Feed charge at barn for hay, water \$1.25/head/day.
- Postage to mail tags will be deducted from sale check.
- All cattle will be required to have a CHB tag...**Tag orders will be available Sept 1, 2022.**
- Transportation to the sale is the seller's responsibility. Sale committee can assist in pooling loads
- Send in registration/tag order by December 9th, 2022.

***** NEW 2022-2023 PRECONDITIONING REQUIREMENTS*****

- **Veterinary Certified**
- Calves must be weaned a minimum 45 days prior to sale date
- Calves must have a Carthage Livestock tag -We will use the EID tags. No prior year tags allowed.
- Calves should have dewormer at Pre-weaning or Weaning time
2 doses, one pour-on and one white oral
- Two rounds of Vaccinations
 - a. Modified Live Vaccine (BVD Type 1a & 2), IBR, PI3, BRSV
 - b. Pasteurella (Both Mannheimia haemolytica and Pasteurella multocida)
 - c. Two rounds of Clostridial Vaccine
 - d. Haemophilus Somnus
- Adjusted to feed bunks and water tank
- Castrated (healed, not clamped) and dehorned (healed)
- **The attached vet form must be signed by your veterinarian and submitted to our office prior to the sale!**

Dear Consignors:

Welcome to the **16th ANNUAL GREATER MIDWEST CERTIFIED HEREFORD FEEDER CALF SALE!** Our team at Carthage Livestock, look forward to welcoming you to the sale on Thursday, January 5th, 2023. It is hard to imagine the event started 16 years ago. It has been our pleasure to watch this event grow as it benefits producers with Hereford or Hereford Influenced cattle as well feed lots that demand a specific, higher value product in their feed yards.

As you review the linked materials for the sale, we understand it can be overwhelming. Please, reach out to me or your veterinarian with any questions. Most large animal focused practices should be able to facilitate these requirements. It is imperative to the success of the masses and the individuals that these protocols are followed and that a veterinarian is involved. These guidelines have come from our years of selling preconditioned cattle, feedback from cosigners and the buyer/feed yards.

A few very important points to outline:

1. Please make an appointment with your veterinarian and take these documents as soon as possible.
2. Please plan to order the required tags for your calves before starting the preconditioning process by calling Kris at 309-333-1048 immediately.
3. It is important that all producers understand the requirements are for the benefit of all cosigners and the order buyer/feed yards that are actively supporting this specialty sale. **IT IS IMPERATIVE TO PARTICIPATE THAT THESE PROTOCOLS, PRODUCT SELECTIONS AND VETERNARIAN CERTIFICATION BE FOLLOWED.**
 - a. These requirements allow for co-mingling, which increases our ability to meet the pot-load request from our feed yards.
 - b. These requirements also ensure less respiratory breaks when the cattle have all been preconditioned. The buyers will pay more for preconditioned cattle and that has allowed us to build relationships with the yards and help producers be paid additional premiums. Consistency in the Preconditioning Program makes a significant difference for the sellers & buyers.
4. These second round of vaccinations must be given before December 10th, approximately 3 weeks prior to the sale.
5. *******NEW IN 2021***** Inforce 3 or NASELGEN 3 has been added to this year's sale protocols, at first or second round.**
6. Preconditioning can begin with two timeframes:
 - a. Pre-weaning when calves go back out with cows.
 - b. Weaning
 - c. Boosters should be administered according to manufacturer label directions
7. We also encourage you to discuss cow protocols with vaccinations and deworming schedules. Great cow health care equates to great calf health. This program is mandating Modified Live Vaccines, so cow vaccination programs are critical.

Please feel free to contact me with any questions at any time. We want everyone involved to feel supported and the reputation of this sale to stay strong for year to come. See you in January.

1. POUR ON DEWORMER – One dose: mandatory, Second dose: strongly encouraged
2. ORAL LIQUID DEWORMER -One Dose: optional

1. A veterinarian must be involved from start to finish, please consult with your veterinarian immediately
2. Veterinarian must sign off on the preconditioning program to participate in this sale
3. Vaccines can be done with Pre-Weaning or Weaning Vaccination Program
4. Branded products are preferred
5. The second round of vaccines should be given before December 10th.
6. The paperwork should be faxed to the barn prior to the sale date from your veterinarian
